RULES/WEIGHTS/DIVISIONS: - see www.txusaw.com. Rookie wrestler means no match any style, anywhere, before 3/15/25. Ineligible Rookie entries subject to deletion with no refund. Rookie tournament will be Madison bracketed into 8-16 man brackets whenever possible. No double entries allowed in Open. Wrestlers in Rookie & Girls may also enter Open division. Open weights <5 entries may be combined in round-robin.

COACHES: All coaches **MUST** display USAW ID on lanyard around neck. 2 coaches per corner on the mat. No parents allowed on the arena floor. Coaches' Passes: 1 per every 4 entries. Additional passes are \$20 each.

WEIGH-INS: *Wrestlers must bring copy of USAW card to weigh-in*

Rookie&Tots: Rookie and Tot *only* entries use Thursday club weigh-in per region policies. See USAW event page for full details. Coaches must enter weights by 10pm Friday, Jan 23.
